#### **Tools Needed:**

Phillips screw driver, 7/32 drill bit, jigsaw, 5/16 wrench, 1/16 allen key, 1/8 allen key, 1/8 allen T-handle and 5/32 allen T-handle.

### Mounting Hardware:

We supply #10 x1-1/4 long wood screws. DO NOT OVERTIGHTEN! Improper installation will trigger corrosion and will void the warranty. It is best to use grease in the screw holes to prevent chipping the powder coat.


#### Mounting Templates:

- Page 9 & 10 are the drill templates. If you are printing these instructions from online make sure the printer was set to 100%. Checked the scaled line on the print.
- Page 11 & 12 shows the dimensions for the control depth and movement.
- Make sure controls are mounted on a flat surface.
- Tape template to the mounting surface.
- Drill the (4) 7/32 corner.
- Use jigsaw to cutout hole for the control to slide into.

### Cables:

- These controls utilize 33 series cables. It is recommend to install new cables with these new controls. Hardin Marine carries all different length cables in stock.
- Attached the new cable to the old cable. When you pull the old cable out it will route the new cable into the original spot.
- The following pages will show cable adjustment.





### Cable Pivot:

- 1. Use a 1/8 allen T-handle to remove all the cable clamps and hardware.
- Starting from the far end. Align all of the swivel discs so Thandle can slide thru.



### Cable End:


- 1) Turning clockwise, screw cable end onto the cable
- 2) Apply anti-seize to the cable end attachment bolt.
- 3) Install bolt using 1/8 allen key.
- Adjust cable.
- When cable is properly adjusted, tighten nut using 5/16 wrench.
- 6) WARNING make sure cables are properly adjusted before starting engine and using the boat.





### Cable Stop:

- 1) Using a 1/16 allen key, turn counter clockwise till set screw touches the lever, Fig A at the end of cable movement.
- Adjust both forward and rear stops the same way.




### **Neutral Safety:**


- 1) Bottom spade goes to the key start side of the key switch.
- 2) The center spade is to the starter.
- 3) Top spade is not used.




### **Single Button Wiring:**

1) Same port or starboard on the knob.










#### Shift Lever Detent:

- 1) Push shift lever forward.
- 2) Using a 5/32 T-handle rotate the set screw clockwise.
- 3) Shift lever only has the neutral detent.
- 4) WARNING: Over tightening will damage the spring. If you coil bind the spring the ball will score into axle and will not be covered by warranty.



### **Throttle Lever Detent:**

- 1) Push throttle lever forward.
- 2) Using a 5/32 T-handle rotate the set screw clockwise to put more pressure.
- 3) Throttle lever has 2 detent balls.
- 4) WARNING: Over tightening will damage the spring. If you coil bind the spring the ball will score the axle and will not be covered by warranty.






#### **Tensioner Adjustment:**


- Adjustment can be done from the top.
- 2) For both shift and throttle, move lever to the rear of the control.
- Using 5/32 t-handle turn clockwise to put more pressure. These are not spring loaded.




#### Maintenance:

- 1) Every 6 months lubricate the inside slit area of the rubber boots with 303 lubricant. We supply small bottle.
- If salt build up or if or sticking is observed on the handle switches, rinse the affected area with fresh water and apply a water displacing lubricant
- If levers become sticky, apply Mercury 2-4-C lubricate between lever and plate.
